I am Academic lead for Trauma and Orthopaedics, NIHR Clinical Academic Training Programme South Yorkshire (2014-). I led the establishment of the South Yorkshire and North Derbyshire Musculoskeletal Biobank in 2009, now in its 13<sup>th</sup> year, overseeing over 60 projects that use its >500,000 sample resource. Projects using this facility have helped uncover biological mechanisms, biomarkers and novel therapeutic avenues for osteoarthritis and osteoporosis, as well as adverse responses to joint replacement prostheses. I sit on the UoS Committee for Human Tissue in Research (2010-), which oversees local implementation of the act and the running of the shared Biorepository. I sit on the Mellanby Centre management committee, which aims to improve collaboration between research groups within the University that have an interest in hard tissues. I chaired the Sir Ernest Finch Memorial Management Committee (2014-2020), that reviews and provides funding for trainees to attend both national and international research and educational meetings

## **4 PROFESSIONAL AND EXTERNAL STANDING**

### **4.1 COMMITTEE MEMBERSHIP AND REVIEW BODY ACTIVITY:**

Local: I chaired the Sir Ernest Finch Memorial Management Committee that funds educational opportunities for surgical trainees (2012-2020). I was an expert member of the Sheffield NRES ethics committee from 2008-2011.

National:

I am a trustee of the National Association for the Relief of Paget's Disease (2022-), and sit on its finance and scientific advisory committees. I sit as NIHR HTA RACER-Hip trial Data Monitoring committee member (2021-). I was Chair of the Board of Trustees (2018-2021) and President (2016-2018) of the British Orthopaedic Research Society (BORS). I led the establishment of the society as a Charitable Incorporated Organisation with the Charity Commission and developed the current constitution. During my tenure young membership of the society increased by 30%. I was the Orthopaedic expert member for the National Institute for health and Care Excellence osteoarthritis guideline committee (2019-2022). We develop the guidance for clinicians and policy makers for this condition that constitutes the NHS's 4<sup>th</sup> largest budget item.

I was appointed (2014) as chair of the Research Committee of the National Joint Registry (NJR), the world's largest surgical audit programme, holding ~3.7 million patient records, and chair its PROMS working group and data alignment working group. I am also appointed by the Department of Health as a member of the NJR's Steering Committee and executive, and sit as a member of its Medical Advisory Committee, and Editorial Board. The NJR develops the evidence base to improve clinical and cost effectiveness through identifying best practice procedures & prostheses that inform health-care policy. We were cited in Parliament in 2020 (Cumberledge report) as a global exemplar of healthcare audit. In this role I have developed initiatives to improve information governance and transparency, ethics, and efficiency of the data sharing, including future research strategy & research priorities, promoting access to data, and establishing links to other datasets. We lead national clinical governance, providing surgeon performance metrics used in appraisal process and by NHS choices to inform the public of surgeon's outcomes. We report on prosthesis performance and related surgical risks through our annual report and by liaison with MHRA. The NJR Medical Advisory Committee role involves advising on specific surgeon-related issues.

I am a member of the MHRA Orthopaedic Experts Advisory Group (2015-) that advises MHRA on implant safety issues in relation to metal-on-metal prostheses.

I sat on the Research Committee of the British Orthopaedic Association (2007 to 2015), the national society for orthopaedics, which guides BOA research policy. I sit as an expert advisor



for the AR-UK Publications Advisory Group, which publishes patient information and as a public spokesperson for the charity. I was a Research sub-committee member for Arthritis Research UK (2011-2014), the UK's largest musculoskeletal charity, which involves panel reviewing 150 project grants per year, and sat on AR-UK's Metabolic Bone Disease Clinical Studies Group (2008-2013), which sets the agenda for clinic studies in this areas.

#### RESEARCH AND PUBLICATIONS

##### 5.1 RESEARCH AREAS AND IMPACT

In the UK 25% of adults older than 65 years suffer pain and disability due to osteoarthritis. My work has focussed on the causes and treatment of arthritis, and also on the biological effects of joint prostheses on the patient.

I have been a key member of various consortia that have sought to better understand the molecular biology of osteoarthritis, identify to date over 800 genetic loci for the disease, and also understanding the causal mechanisms behind these associations at the genomic level, including transcribed signal, proteomics and epigenetic regulation. These advances have led to multiple high impact publications, including Lancet, Cell, Nature Genetics, and multiple other translational and basic science journals, and will one day transform our management of the disease.

My other areas of research include the identification of novel biomarkers and imaging techniques for detecting osteolysis, exploration of the molecular mechanisms that underpin its development and novel pharmacological strategies for its treatment, and the systemic health effects of metal ion exposure after hip resurfacing.

I was the first to use National Joint Registries as a mechanism to study the biology of rare musculoskeletal diseases and immune reactions to prostheses. I have recruited over 5,000 subjects in the UK and Norway using this methodology. I was the first researcher to show that genetic polymorphism influences the risk of osteolysis and of heterotopic ossification after hip replacement, and the first to demonstrate differences in innate immune responses between high and low risk individuals. I quantitated the relationship between prosthesis wear and failure, and published the first clinical trial of bisphosphonate use as a pharmacological intervention after hip replacement (2001). I am chief investigator for the first phase-2 clinical trial to study the effect of monoclonal antibody therapy to modulate the effects of adverse reactions to prostheses (EUDRACT Number 2011-000541-20). This study showed the effect of denosumab on osteolytic activity, a first for this disease (Lancet Rheumatology 2021).

The beneficiaries of my work are patients with OA or undergoing joint replacements, whose quality of life will be improved by the amelioration of avoidable risks, through novel approaches to genetic analysis, immunology and epidemiology. The NHS benefits by stratification of patients by prognostic risk, more intelligent use of resources, and enlarged repertoire of therapies.

#### 5.5 Research in Progress and future work

My current research areas include the genetics and genomics of osteoarthritis, use of national and international datasets to inform the development of personalized health forecasting tools for osteoarthritis and for patients after joint replacement, characterising the epidemiology of adverse systemic effect of metal exposure. I participate in a consortium examining effect of endophenotype on genetic susceptibility to OA hip and knee, and examining the genetic determinants of hip shape. I work closely with collaborators at the Helmholtz Institute on

Munich to study the functional genomics of osteoarthritis. I collaborate with Bristol University and University of East Anglia examining effect of ethnicity on joint replacement incidence in England, Wales and Northern Ireland, on joint replacement epidemiology in inflammatory arthritis, and on hip replacement outcomes in spina bifida. I also have research collaborations within UoS, for example including the functional relevance of genetic polymorphisms on gene activity (E Kiss-Toth), the effect of metal ions after MOMHR on systemic and bone health (multiple collaborators). My recent and current clinical trial work includes the effect of monoclonal antibody therapy on osteolysis (PI), the effect of biologic therapy on outcomes of orthopaedic surgery in inflammatory arthritis Co-I), and effect of bisphosphonates on fracture healing (Co-I).
